Clause 30. BY-LAWS

1. The Committee is empowered to make by-laws that are not inconsistent with the constitution. The Committee may repeal and amend such by-laws as they may from time to time consider necessary for the wellbeing of the Club, which by-laws, repeals and amendments will have effect until otherwise determined by the Committee or General Meeting.

5.(1) All memberships are at the discretion of the committee and may be rejected with no cause given.

5.(2) The individual makes application for membership as set out in the Archery Australia Rules or Club By-laws.

- a. Must have completed a minimum of 1 (One) Come and Try Session.
- b. Must have successfully completed applicable inductions or other courses as determined by the club committee, having completed all relevant documentation in full.
- c. The Club Coach or assessor must then advise the Club Secretary that the applicant is now eligible to join Liverpool City Archers.
- d. The applicant then pays their Membership fees on-line to AA through the membership portal as outlined by AA, who then will distribute the applicable funds to LCA.
- e. The applicant is then given their membership details by AA and their membership commences from that time until the expiry date.
- f. The individual is then eligible to shoot at the club with the proviso that there must be another Club member always present who holds a Key to the grounds while they are there as per rules and regulations outlined.

5.(3). Any members who transfer full Membership or applies for memberships from another Club:

- a. Must have successfully completed applicable inductions or other courses as determined by the club committee, having completed all relevant documentation in full.

(ii) A member requesting to transfer to LCA will be required to provide a reference from their registered Archery Australia affiliated club.
- b. The Club Coach or assessor must then advise the Club Secretary that the applicant is now eligible to join Liverpool City Archers.
- c. The applicant then pays the club portion of the fee's pro rata to coincide with the end date of their current affiliation.

- d. The club secretary shall then advise the member they are a full member of LCA.
- e. The individual is then eligible to shoot at the club with the proviso that there must be another Club member always present who holds a Key to the grounds while they are there as per rules and regulations outlined.

5. (4). All applicants for Associate Membership:

- a. Must be a current financial member of another AA club.
- b. Must have successfully completed applicable inductions or other courses as determined by the club committee, having completed all relevant documentation in full.
 - (ii) A member requesting to transfer to LCA will be required to provide a reference from their registered Archery Australia affiliated club.
- c. The Club Coach or assessor must then advise the Club Secretary that the applicant is now eligible to join Liverpool City Archers as an associate member.
- d. The applicant will pay membership fee directly to LCA pro-rata club portion to cover membership to the next date of renewal of main club membership.
- e. The applicant is then given their membership details by AA and their membership commences from that time until the expiry date.
- f. The individual is then eligible to shoot at the club with the proviso that there must be another Club member always present who holds a Key to the grounds while they are there as per rules and regulations outlined.

5.(5). All new members will be subject to a minimum of a six-month Probationary period.

- a. Any members not complying with the club (LCA) rules or bringing the club into disrepute may have their membership terminated without reference to any sections of the constitution.
- b. All applications for membership may be reviewed by the Committee.
- c. The committee may at its discretion, refuse an application for membership and, if so, requested by the applicant, may provide written advice as to the reason *for* such refusal in line with the NSW Fair trading Act.
- d. The appointed Club Secretary shall keep a record of each member's details as soon as practical after advising AA. All personal details are to be held in strict confidence
